TOURNAMENT RULES

1. All participants entering in this tournament **MUST** be a female WY-JON County USBC member prior to the start of competition. Memberships can be purchased the day of the tournament.
2. Participants can compete in the team event 2 times provided at least two members are different.
3. Each team consists of four participants with no more than one member from the PBA exempt list on said team. Team participants do not have to compete in singles/doubles events.
4. Contestants entering the doubles event must also enter the singles event and vice versa. The first three games will be bowled on one pair of assigned lanes, and then the next set of three games will be bowled on the opposite pair of lanes. Singles/doubles participants do not have to compete in team event.
5. Entrants shall use their highest league average from the 2016-2017 season unless current average of 21 or more games bowled is 10 pins or more higher as of January 1, 2018, in which case they must use current average regardless of where their average is established. Please supply documentation when entering.
6. Entrants, who do not have a current average and/or cannot provide average proof, will bowl scratch which is 220.
7. All entrants are responsible for verifying that their average is accurate at the time of bowling or forfeit any earned prizes.
8. No entry applications will be accepted unless accompanied by the required entry fees.
9. We agree to abide by all tournament rules and USBC regulations governing tournament competition. We also warrant that we are USBC members in good standing and will bowl on the lanes assigned to us.
10. In the event of mechanical failure, it is hereby agreed that the bowlers affected shall be moved to the next available pair of lanes in the center.
11. Each individual bowler is held responsible for rules violations. Any entrant appearing at his/her scheduled time of bowling who appears to be under the influence of intoxicating liquors, or any entrant who willfully delays the normal progress of the game, or any entrant whose conduct on the lanes is considered objectionable, shall be disqualified and immediately removed from the lanes, regardless whether a qualified substitute is available or not.
12. All entrants will be handicapped 90% of the difference between their average and 220.
13. Payout ratio: 1 out of every 6 entries will cash in this tournament.
14. Copies of the score sheets will be available as soon as scores have been checked by the tournament office. Original score sheets are official and any obvious errors are subject to change and correction by the tournament director. All protests concerning errors in scoring or errors in calculation must be made within 24 hours after the event.
15. All entries are due in the Wy-Jon County USBC office by 5:00 p.m., Wednesday, January 17, 2018.
