TOURNAMENT RULES

1. All participants entering in this tournament MUST be a WY-JON County USBC member prior to the start of competition. Memberships can be purchased the day of the tournament.
2. This is a SENIORS event and all participants must be 50 years or older in age the day of the tournament.
3. All participants shall use their highest league average from the 2016-2017 season (winter or summer) of at least 21 games or their current average if it exceeds their last year's average by 10 pins or more as of January 1, 2018, regardless of where average was established. Documentation must be supplied with entry form.
4. Participants, who do not have an established average under #3 above, shall use a 230 average.
5. It is the responsibility of the bowler to verify their average prior to commencement of competition or be subject to disqualification.
6. All participants must enter both singles and doubles. All six games will be bowled on the same pair of assigned lanes.
7. All entry forms, INCLUDING ENTRY FEE, must be submitted by close of business, Friday, May 4, 2018.
8. Each participant agrees to abide by all tournament rules and USBC regulations governing tournament competition and warrant that they are USBC members in good standing.
9. In the event of mechanical failure, it is hereby agreed that the bowlers affected shall be moved to the next available pair of lanes in the center.
10. Each participant is held accountable for any rules violations. Any participant who appears to be under the influence of intoxicating liquors, and/or any participant who willfully delays the normal progress of the game, or any participant whose conduct on the lanes is considered objectionable, shall be disqualified and immediately removed from the center, whether or not a qualified substitute is available.
11. This is a handicap tournament. The handicap is 90% of the difference between 690 and the participant's entering series average.
12. Payout ratio for this tournament is 1 for 6, meaning 1 participant will cash for every 6 participants entered. Prize fund will be distributed within 30 days after the end of the tournament.
13. Copies of the score sheets will be available as soon as scores have been checked by the tournament officials. Original score sheets are official and any obvious errors are subject to change or corrections by tournament director. All protests concerning errors in scoring or errors in calculation must be made in writing, within 24 hours after conclusion of the event.
14. Any rules not covered specifically by these rules will be governed by USBC rules.
